letter "P" for enclosure with additional protection

15.2 Description

The three-phase cage motor is designed in type of protection Flameproof enclosure for the stator housing and in type of protection Increased safety or Flameproof enclosure for the terminal box.

Duty type S1:

For direct temperature monitoring the stator windings of the motor are optionally equipped with temperature sensors (PTC DIN 44081).

Duty type S2 up to S10:

For direct temperature monitoring the stator windings of the motor are equipped with 3 temperature sensors (PTC DIN 44081-145). The temperature sensors are connected in series and will be connected to a control unit which is certified for this purpose.

Around the terminal box the motor enclosure is optionally equipped with an additional protective enclosure (additional protection).

Optionally the stator housing is equipped with an anti-condensation heater.
